## *Resolution No. 1999-167*

A RESOLUTION AUTHORIZING THE COUNTY OF SANTA FE  
TO SUBMIT AN APPLICATION TO  
THE DEPARTMENT OF FINANCE AND ADMINISTRATION,  
LOCAL GOVERNMENT DIVISION TO PARTICIPATE IN THE  
LOCAL DWI GRANT AND DISTRIBUTION PROGRAM

**WHEREAS**, the Legislature enacted Section 11-6A-1 through 11-6A-6 NMSA (1978) as amended to address the serious problems of Driving While Intoxicated/Impaired in the State; and

**WHEREAS**, a program is established to grant and distribution funding available to counties and municipalities for new, innovative or model programs, services, or activities to prevent or reduce the incidence of DWI, alcoholism and alcohol abuse; and

**WHEREAS**, the county DWI Planning Council's and other governmental entities' approval must be received in order to apply for grant and distribution funding; and

**WHEREAS**, Santa Fe County is making application to the Department of Finance and Administration, Local Government Division, for a grant to build an Assessment, Detoxification, and Treatment Center for DWI offenders; and

**WHEREAS**, Santa Fe County is making application to the Department of Finance and Administration, Local Government Division, for disbursement funds to support a DWI Program to prevent the incidence of DWI and of alcohol-related problems in Santa Fe County.

**NOW, THEREFORE, BE IT RESOLVED** by the Santa Fe Board of County Commissioners, that the County Commission Chairperson, on behalf of the County and all participating entities, is authorized to submit an application for grant and/or distribution program funding under the rules and regulations established by the Local Government Division.
