*Resolution No. 1999-54*

## A RESOLUTION SUPPORTING A GRANT APPLICATION TO NEW MEXICO STATE PARKS DIVISION

WHEREAS, the Federal Recreation Trails Program (RTP), or "TEA 21," funds New Mexico State Parks Division's Recreational Trails Funding Program. In FY99, the New Mexico funding allocation for this program is \$942,000. The program provides an 80 percent federal match for each project with 20 percent local match;

WHEREAS, in 1997 Santa Fe County acquired an 11.5 mile easement along the Santa Fe Southern railroad, known as the Santa Fe Rail Trail;

WHEREAS, the Santa Fe Rail Trail is an important link between the City of Santa Fe and outlying County population centers including Rancho Viejo, Eldorado and Lamy;

WHEREAS, the County intends to expand on this trail as part of a regional system;

WHEREAS, Rancho Viejo Limited Partnership and Rancho Viejo de Santa Fe have agreed to donate easements for approximately two (2) miles of trail ("Rancho Viejo Spur Trail") to Santa Fe Conservation Trust, which land value will be used as the local matching grant amount;


WHEREAS, Santa Fe County, in partnership with Santa Fe Conservation Trust, wishes to receive funding to oversee improvements of the new trail to the Community College with two trailheads.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners (BCC) of Santa Fe County that we approve for the joint Recreational Trails Program application to be submitted to the New Mexico State Parks Division.

**PASSED, APPROVED AND ADOPTED** this 27<sup>th</sup> of April, 1999.


