Resolution No. 1999-79

A RESOLUTION CALLING FOR COMBINED CITY/COUNTY MEETINGS TO REVIEW THE HIGHWAY CORRIDOR PLAN FOR LANDS ALONG INTERSTATE 25 AND STATE HIGHWAY (NM) 599.

WHEREAS, the City and County adopted a Joint Resolution creating a Highway Corridor Planning Committee and charged that committee with developing a plan for lands along Interstate 25 and NM 599 (City Resolution No. 1998-30 and County Resolution No. 1998-45);

WHEREAS, the City and County adopted a Joint Resolution requiring cooperation between City and County for Regional Planning (City Resolution No. 1998-19 and County Resolution No. 1998-30);

WHEREAS, the appointed Highway Corridor Planning Committee met over a period of ten months and developed a Highway Corridor Plan which addresses land use and land development design standards along approximately 15 miles of I-25 and approximately 15 miles of NM 599;

WHEREAS, consideration of the committee's plan and action on that plan is necessary by the City and County to further the efforts of effective planning and growth management; and

WHEREAS, the City adopted Resolution No. 1999-61 on June 30, 1999 proposing a similar action, with the exception of the following proposed joint study session (Item 2) and combining the Extraterritorial Zoning Authority meeting into Item 4 below.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners (BCC) of Santa Fe County that:


1. The City Manager and County Manager are directed to schedule a series of combined City/County meetings to review the Highway Corridor Plan.
2. The first combined meeting should be a joint study session with the City Council and Board of County Commission (July, 1999).

3. The second combined meeting should include the City Planning Commission, Extraterritorial Zoning Commission, and County Development Review Committee in combined session to hear and make recommendations regarding the proposed Highway Corridor Plan (August, 1999).
4. The final meeting should be a joint Extraterritorial Zoning Authority, City Council, and Board of County Commission public hearing to review and adopt the Highway Corridor Plan as amendments to the respective Extraterritorial Plan, City General Plan and County Growth Management Plan (September, 1999).






