RESOLUTION NO. 2002 - 100

A RESOLUTION CONDITIONALLY ACCEPTING MORNING DRIVE, MORNING STREET AND MORNING LANE FOR COUNTY MAINTENANCE

Whereas, Santa Fe County encompasses a geographical area of approximately 2,000 square miles; and

Whereas, the County is primarily rural with small areas of concentrated development; and

Whereas, a comprehensive road system is a necessary and vital link between communities; and

Whereas, there are an estimated 1,500 total miles of roads within the County; and

Whereas, of the total miles, approximately 577 miles are recognized as County Roads and maintained by the County; and

Whereas, the County's goal is to provide the best services possible to its residents within the available resources; and

Whereas, Morning Drive, Morning Street and Morning Lane are located within Santa Fe County; and

Whereas, the residents of the Jimenez Subdivision (tracts C & D), Sally Thayer (tract B) and Allsup's Convenience Stores Inc. (tract A) have asked the County to accept and provide maintenance on Morning Drive, Morning Street and Morning Lane as shown on Exhibit A; and

Whereas, the County has the authority and capability to accept these roads for maintenance; and

Whereas, the residents of the Jimenez Subdivision (tracts C & D), Sally Thayer (tract B) and Allsups Convenience Stores Inc. (tract A) have met all the requirements in the Road Acceptance Policy, Resolution 1998-119, Exhibit B; and

Whereas, the County has conducted an inspection on these roads; and has generated a punch list of deficiencies attached, Exhibit C; and

Whereas, the County is requiring the items on the punch list, Exhibit C, to be completed prior to assuming maintenance; and

Whereas, the County will conduct a final inspection after the items on the punch list, Exhibit C, are completed prior to beginning maintenance; and

Whereas, the County Manager and the Public Works Director will sign a document acknowledging the items on the punch list, Exhibit C, have been completed to the County's satisfaction; and

Whereas, the Board of County Commissioners believes it to be in the best interest of the residents to accept these roads; and


NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners conditionally accepts Morning Drive, Morning Street and Morning Lane for County maintenance.

- ***Morning Drive***, An asphalt, 20 feet wide driving surface road, beginning at intersection with Agua Fria Street and continuing south to the dead end, a distance of 0.5 miles. The acceptance is conditional upon completion of the punch list (Exhibit C).
- ***Morning Street***, An asphalt, 20 feet wide driving surface road, beginning at the intersection with Morning Drive and continuing west to the dead end, a distance of 0.035 miles. The acceptance is conditional upon completion of the punch list (Exhibit C).
- ***Morning Lane***, An asphalt, 20 feet wide driving surface road, beginning at the intersection with Morning Drive and continuing west to the dead end, a distance of 0.035 miles. The acceptance is conditional upon completion of the punch list (Exhibit C).

Santa Fe County does not accept any maintenance responsibility for residential driveways or drainage structures on driveways. It is advisable that residents repair damaged culverts and reinstall culverts to the proper flow line elevation. In the event that improper installation or lack of maintenance of drainage structures causes

damage to the County maintained road, the County reserves the right to collect damages for repair against the responsible party.


