**A RESOLUTION ADOPTING A WATER SERVICE AGREEMENT
FEE FOR APPLICANTS REQUESTING WATER SERVICE FROM
THE SANTA FE COUNTY WATER UTILITY PURSUANT TO
RESOLUTION NO. 1998-13.**

WHEREAS, Santa Fe County ("County") provides water service to certain areas in the County through its Utilities Department Water Utility ("SFC Water Utility"); and

WHEREAS, water is an essential but limited resource which must be wisely and efficiently utilized; and

WHEREAS, the resources available to the SFC Water Utility to provide water service are finite and limited; and

WHEREAS, the SFC Water Utility must address requests for water service on a timely basis; and

WHEREAS, the SFC Water Utility incurs costs associated with the review, evaluation and processing of water service requests that require a water service agreement pursuant to Resolution No. 1998-13; and

WHEREAS, it is in the best interest of the County and the SFC Water Utility to recover its costs associated with the review, evaluation and processing of a Water Service Agreement;

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe Board of County Commissioners hereby approves and adopts a Water Service Agreement Fee of \$500 for the purpose of reimbursing the County for costs it incurs for the review, evaluation and processing of a Water Service Agreement.

BE IT FURTHER RESOLVED that the Water Service Agreement Fee is effective July 31, 2002 and the SFC Water Utility shall prepare and submit a Rate Schedule, for ratification by the Santa Fe Board of County Commissioners at its next regularly scheduled BCC meeting on August 13, 2002.
