SIGNATURE AUTHORITY REGARDING THE REGIONAL WATER SYSTEM  
FEASIBILITY STUDY FOR CUATRO VILLAS**

WHEREAS, the State of New Mexico Legislature has allocated funds through the New Mexico Environment Department for the purposes of a regional small community water system feasibility study; and

WHEREAS, the project was funded in the amount of \$62, 683.90 with no local match and is further identified as project number SAP-02-1453-GF; and

WHEREAS, Roman Abeyta, Land Use Department Director is designated as the official representative authorized to submit final and any documents pertaining to the project; and

WHEREAS, Estevan Lopez, County Manager is designated as the signatory authority to sign and submit reimbursement requests.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of County Commissioners (BCC) of Santa Fe County supports the proposed project and designates Roman Abeyta, Land Use Director as the official representative authorized to submit final and any documents pertaining to the project; and designates Estevan Lopez, County Manager as the signatory authority authorized to sign and submit reimbursement requests.


