A RESOLUTION DESIGNATING GRANTEE SIGNATURE AUTHORITY AND PROJECT REPRESENTATIVE REGARDING THE CAMINO POLVOSO SEWER LINE PROJECT

WHEREAS, the State of New Mexico Legislature has allocated funds through the New Mexico Environment Department for a wastewater project; and

WHEREAS, the Camino Polvoso sewer line project was funded \$63,000 with no required local match and identified as project number SAP-04-1555-STB;

NOW, THEREFORE, BE IT RESOLVED, that at a meeting of the Board of County Commissioners for Santa Fe County held on August 31, 2004, the governing body adopted and passed this resolution authorizing the County Commission Chairperson to sign the agreements for these projects and appointing the County Manager, or the Utilities Department Director, or Utilities Department Deputy Director as the GRANTEE PROJECT REPRESENTATIVE(S). Grantee representatives are authorized to submit any documents pertaining to the project and act as the single point of contact; and

BE IT FURTHER RESOLVED, that this resolution appoints the Field Operations Manager, or the Enterprise Fund Accountant, or the Utilities Department Administrative Assistant, as the GRANTEE SIGNATORY AUTHORITIES. Signatory authorities are authorized to sign reimbursement requests and other documents requiring a signature for submittal to the New Mexico Environment Department.
