Resolution 2004 - 114

Regarding "State of the Schools" Address to the Community and Local Governing Bodies

WHEREAS, the Santa Fe Public School Board of Education (the "Board of Education") understands that Education is of vital importance to the entire community and that, accordingly, the entire community should be actively engaged in addressing Educational issues; and

WHEREAS, such active engagement requires a regular flow of information from the Board of Education to the general public and the Santa Fe City Council and the Board of County Commissioners of the County of Santa Fe (collectively, "Local Governing Bodies"); and

WHEREAS, to achieve the goal of an informed and engaged community at large, the Board of Education desires to formally present information pertinent to the Santa Fe Public Schools to the Local Governing Bodies and the general public through an annual report and an annual address.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Santa Fe ("BCC") that the Superintendent of the Santa Fe Public Schools and the President of the Board of Education shall prepare an annual "State of the Schools" report and deliver an annual "State of the Schools" address to the BCC.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the BCC that the "State of the Schools" address (i) shall be presented annually during its second meeting of the month of September and (ii) shall include the following and other appropriate subjects:

- Significant accomplishments of the Santa Fe Public School District;
- Current issues facing the Santa Fe Public School District;
- Established objectives of the Santa Fe Public School District and fundamental philosophies on how to achieve those objectives;
- How specific decisions made by Local Governing Bodies have affected the Santa Fe Public School District;
- Fiscal outlook of the Santa Fe Public School District;
- Teacher retention; and


