Resolution No. 2005-1

A RESOLUTION IN SUPPORT OF THE GOVERNOR'S DWI LEGISLATIVE PACKAGE

WHEREAS, the citizens of Santa Fe County and the communities of the State of New Mexico need to be assured that their roads are safe; and

WHEREAS, driving while impaired ("DWI") poses great risk to the public's health, safety, and welfare; and

WHEREAS, continued preventative measures must be undertaken to reduce traffic-related fatalities, injuries, and crashes caused by persons driving while under the influence of intoxicating liquor; and

WHEREAS, the mission of the Santa Fe County DWI Planning Council is to prevent or reduce the incidence of DWI in Santa Fe County; and

WHEREAS, the Santa Fe County DWI Planning Council supports the Governor's DWI Legislative Package for the 2005 Regular Legislative Session; and

WHEREAS, Governor Bill Richardson has initiated a DWI Legislative Package for the 2005 Regular Legislative Session to prevent or reduce the incidence of DWI in New Mexico through bills entitled as follows:

1. RELATING TO DRIVING WHILE UNDER THE INFLUENCE OF INTOXICATING LIQUOR; LOWERING THE LEGAL ALCOHOL CONCENTRATION LEVEL FOR PERSONS WITH A PRIOR DWI CONVICTION.
2. RELATING TO DRIVING WHILE UNDER THE INFLUENCE OF INTOXICATING LIQUOR OR DRUGS; REQUIRING ALL OFFENDERS TO HAVE AN IGNITION INTERLOCK DEVICE INSTALLED.
3. RELATING TO ALCOHOL; CREATING A DRUNKBUSTERS HOTLINE TO REPORT DWI AND THE SALE OR PROVISION OF ALCOHOL TO PERSONS UNDER TWENTY-ONE YEARS OF AGE; CREATING A FUND; ESTABLISHING A FEE; MAKING AN APPROPRIATION.

4. RELATING TO ALCOHOLIC BEVERAGES; CREATING LOCAL EMPOWERMENT DISTRICTS; PERMITTING RESTRICTIONS ON ALCOHOL SALES AND SERVICE IN LOCAL EMPOWERMENT DISTRICTS.

NOW THEREFORE, BE IT RESOLVED, that the Santa Fe County Board of County Commissioners supports the aforementioned bills in the Governor's DWI Legislative Package for the 2005 Legislature.






