A RESOLUTION DEDICATING THE ARROYO SECO TEEN CENTER AS THE MARK "MARCOS" P. TRUJILLO TEEN CENTER

WHEREAS, certain areas in Northern New Mexico, specifically Rio Arriba County and Northern Santa Fe County, receive national attention for the numerous problems and tragedies that rampant substance abuse causes in those areas; and

WHEREAS, drug and alcohol abuse and accompanying violence and accidents affects not only the substance abusers themselves but also their entire family and the surrounding community; and

WHEREAS, the numerous problems and tragedies caused by rampant substance abuse have left the younger generations in the communities of Northern New Mexico with a profound sense of loss, despair, and hopelessness for the future; and

WHEREAS, Mark "Marcos" Phillip Trujillo served as Santa Fe County Commissioner for District 1 from 1995 – 2002; and

WHEREAS, during his tenure, Commissioner Trujillo strived to improve the health, education, and well being of the citizens of Northern Santa Fe County, with a particular emphasis on community efforts that provided opportunities for youth; and

WHEREAS, with the guidance and vision of Commissioner Trujillo, and in collaboration with Hands Across Cultures Corp., a teen center to be located in Arroyo Seco was envisioned to serve the youth aged 13 to 19 of Espanola, Pojoaque, Chimayo, and surrounding areas; and

WHEREAS, the envisioned teen center was intended to offer mentoring, arts, poetry, and leadership programs to help local teens live substance-free and take control of their lives and futures; and

WHEREAS, Phase I and Phase II of the Arroyo Seco Teen Center envisioned by Commissioner Trujillo have been completed, bringing the total square footage of the teen center to 4,000, consisting of multipurpose, meeting, and youth activity space; and

WHEREAS, it is appropriate to memorialize Commissioner Trujillo's invaluable contribution to this important project by naming the teen center he envisioned after him.
