Request is to transfer investment earnings realized on bond proceeds in Fiscal Year 2006 from the General Obligation Bond Fund Series 2001 (353) to the GO Bond Debt Service Fund (401).

The bond document requires investment earnings accumulated in the Bond Proceeds Fund (353) to be transferred annually at the end of the fiscal year to the Debt Service Fund (401) and used to pay debt service.
