Resolution No. 2006 - 196

A Resolution in Support of the New Mexico Hispano Music Association During the 2007 Legislative Session

WHEREAS, the New Mexico Hispano Music Association (NMHMA) was created in 1991 as a non-profit corporation and has been in existence for 15 years to help preserve the unique musical culture and heritage of New Mexico Music; and

WHEREAS, NMHMA educates, guides, encourages and promotes New Mexico Hispano musicians, vocalists, composers, and others involved in the creation, production and dissemination of this unique music; and

WHEREAS, NMHMA provides a forum for exchange and dialogue among Hispanic musicians and aficionados to preserve and promote the performance style and repertoire of New Mexico Hispano Music, as well as promote a public understanding of the significance, value and vitality of New Mexico's Hispano Music community; and

WHEREAS, NMHMA creates appropriate venues for the recognition and development of outstanding musicians, songwriters, vocalists and bands in a variety of music categories and styles such as the yearly event known as the Hispano Music Association Awards Show; and

WHEREAS, many of New Mexico's most influential musical artists are from the central and northern parts of the state; and

WHEREAS, the NMHMA has located property in northern Santa Fe County, in which they would like to build a facility, with a museum as the focal point, similar in nature to a Hall of Fame, to be established honoring pioneers in New Mexico Hispano Music; and

WHEREAS, in addition to the Museum, the NMHMA would also utilize the facility for administrative offices, meeting rooms, and space for archiving; and

WHEREAS, the NMHMA will be lobbying during the 2007 Legislative Session for Legislative Capital Outlay Funding in the amount of \$200,000 for Plan, Design and Engineering Services of the proposed facility.



NOW THEREFORE BE IT RESOLVED, that the Santa Fe Board of County Commissioners:

- 1.) Support the New Mexico Hispano Music Association's request for a legislative appropriation during the 2007 legislative session in the amount of \$200,000 to fund Plan, Design and Engineering Services for the Association's Museum/Mixed Use Facility; and
- 2.) Encourages Governor Bill Richardson and the New Mexico Legislature to allocate \$200,000 of Capital Outlay appropriation during the 2007 legislative session to Santa Fe County as the fiscal agent for the NMHMA's project.
