Resolution No. 2006- 61

A RESOLUTION CALLING FOR THE AGUA FRIA COMMUNITY CENTER TO BE RENAMED THE "NANCY RODRIGUEZ COMMUNITY CENTER"

WHEREAS, Senator Nancy Rodriguez has represented the Traditional Village of Agua Fria as a County Commissioner and then as a State Senator for the past 22 years; and

WHEREAS, Senator Nancy Rodriguez also served the people of the Village of Agua Fria as Santa Fe County Manager; and

WHEREAS, through her time and efforts serving in the State Legislature, Senator Rodriguez has been responsible for the appropriation of millions of dollars in state funding to help make many needed improvements for the Village of Agua Fria; and

WHEREAS, the Agua Fria Community Center was the result of the inspiration of Senator Nancy Rodriguez; and

WHEREAS, Senator Nancy Rodriguez has been responsible for the appropriation of nearly \$800,000 in state funding to assist Santa Fe County with the costs for planning, design and construction of the Agua Fria Community Center; and

WHEREAS, Senator Nancy Rodriguez has helped to improve the quality of life for the residents of the Village of Agua Fria through state appropriations to construct sidewalks and build a pedestrian crossing for residents to cross the Santa Fe river; funding to create the Santa Fe River Corridor Park; extension of sewer lines and improvement of the community water system, and initiated funding to help construct La Familia Medical Clinic.


NOW, THEREFORE, BE IT RESOLVED BY THE SANTA FE BOARD OF COUNTY COMMISSIONERS THAT:






