RESOLUTION NO. 2006- 62

A RESOLUTION RESTRICTING TRUCK TRAFFIC ON AGUA FRIA ROAD (COUNTY ROAD 66) BETWEEN THE CITY LIMITS OF THE CITY OF SANTA FE AND ITS INTERSECTION WITH AIRPORT ROAD, INCLUDING SAN FELIPE ROAD; DIRECTING POSTING OF AGUA FRIA ROAD AND SAN FELIPE ROAD, AND DIRECTING STAFF TO FORWARD A COPY OF THIS RESOLUTION TO THE DEPARTMENT OF PUBLIC SAFETY, MOTOR TRANSPORTATION DIVISION.

WHEREAS, the community of Agua Fria and the Traditional Historic Community of Agua Fria, are historic areas that consist of a mix of residential and commercial uses;

WHEREAS, Agua Fria Road, which extends from the City limits of the City of Santa Fe to Airport Road (the latter portion referred to as "San Felipe Road"), is primarily a residential street, but growth along Airport and the completion of NM 599 has created an increase in through truck and commercial motor vehicle traffic on Agua Fria Street, with attendant disruption of the community and increased noise, dust and pollution;

WHEREAS, trucks and commercial motor vehicles appear to be using Agua Fria Street to travel between the intersection of Agua Fria Street and Siler Road to Airport Road and NM 599, exacerbating the problems described in previous paragraph;

WHEREAS, truck and commercial motor vehicle traffic detract from the historical and cultural values of the community and affect the quality of life of residents who live along Agua Fria Street;

WHEREAS, Agua Fria Street is not designated a truck and truck trailer route, and reasonable alternate routes exist for trucks and commercial motor vehicles to travel from the intersection of Agua Fria Street and Siler Road to Airport Road and NM 599;

WHEREAS, NMSA 1978, Section 66-7-415 (1955) gives the Board of County Commission the authority, by resolution or ordinance, to restrict truck and commercial motor vehicle on designated streets in areas that are primarily residential, which prohibitions and limitations shall be designated by appropriate signs placed on such street; and

WHEREAS, the Board of County Commissioners desires to impose such restrictions and to direct staff to place appropriate signs detailing the restrictions, and to transmit a copy of this Resolution to the Department of Public Safety, Motor Transportation Division.

IT IS THEREFORE RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE COUNTY, AS FOLLOWS:

1. Trucks and commercial motor vehicles shall be and hereby are prohibited from through travel on Agua Fria Street (County Road 66) and San Felipe Road between the City limits of the City of Santa and the intersection of Agua Fria Street/San Felipe Road with Airport Road.

2. Trucks and commercial motor vehicles shall be permitted to travel Agua Fria and San Felipe Road for the sole purpose of local deliveries or to access businesses or customers located on Agua Fria/San Felipe Road, or on adjoining streets that can only be accessed from Agua Fria Street.

3. For purposes of this Resolution, the word "truck" shall have the meaning assigned by NMSA 1978, Section 66-1-4.17(N) (1990), but shall apply only to vehicles of gross vehicle weight that exceeds ten (10) tons, regardless of the number of axles and inclusive of any trailer.


4. For purpose of this Resolution, the phrase "commercial motor vehicle" shall have the meaning assigned by NMSA 1978, Section 66-1-4.3(J), but shall apply only to vehicles of gross vehicle weight that exceeds ten (10) tons, regardless of the number of axles and inclusive of any trailer.

5. Staff shall place the appropriate signs describing the restrictions on Agua Fria Street/San Felipe Street, and on adjoining streets whose sole access is from Agua Fria Street. This Resolution shall not become effective until signs are posted.

6. Staff shall transmit a copy of this Resolution to the New Mexico Department of Public Safety, Motor Transportation Division. This Resolution shall not become effective until a copy of this Resolution has been so transmitted.
