A RESOLUTION APPROVING THE SANTA FE COUNTY  
HOUSING AUTHORITY'S UTILITY ALLOWANCE SCHEDULE  
FOR THE SECTION 8 HOUSING CHOICE VOUCHER PROGRAM

WHEREAS, 24 CFR 887.361 mandates that Housing Authorities must establish a utility allowance schedule for the Section 8 Housing Choice Voucher Program; and

WHEREAS, the utility allowance schedule must be reviewed annually to determine if there has been a substantial change in utility rates or other charges of general applicability that would require an adjustment to the utility allowance schedule; and

WHEREAS, the Santa Fe County Housing Authority has reviewed its current utility allowance schedule for the Section 8 Housing Choice Voucher Program and has determined that the allowances need to be adjusted; and

WHEREAS, 24 CFR 887.361 and Form HUD-52667 provide guidance and the recommended procedures for adjusting the utility allowances; and

WHEREAS, the Santa Fe County Housing Authority is establishing new utility allowances for the Section 8 Housing Choice Voucher Program to be effective June 1, 2006. The new utility allowances follow the guidance and procedures set forth in 24 CFR 887.361 and Form HUD-52667 and are set forth in Exhibit A, which is attached to this Resolution.

NOW, THEREFORE BE IT RESOLVED that the Santa Fe County Board of Commissioners hereby approves and adopts the utility allowance schedule attached as Exhibit A for the Section 8 Housing Choice Voucher Program.
