Resolution No. 2006- 93

A RESOLUTION DESIGNATING THE POLLING PLACE OF PRECINCTS 22 AND 28 IN SANTA FE COUNTY, NEW MEXICO

WHEREAS, NMSA 1978, § 1-3-2 (1995) requires that the Board of County Commissioners designate the polling place to be used in the November 7, 2006 General Election of Precincts 22 and 28 in Santa Fe County; and

WHEREAS, Precincts 22 and 28 have previously been located at the De Vargas Mall public atrium, which is located at 564 North Guadalupe Street, Santa Fe, New Mexico; and

WHEREAS, the De Vargas Mall public atrium has become unavailable and thus necessitates a change in the polling location for the Precincts; and

WHEREAS, the Santa Fe County Clerk has identified the nearest, suitable polling place to be the Fort Marcy Complex gymnasium which is located at 490 Bishops Lodge Road, Santa Fe, New Mexico; and

WHEREAS, the Fort Marcy Complex is within Precinct 28 and the Santa Fe County Clerk can identify no other suitable polling place available within Precinct 22; and


WHEREAS, the State Elections Director has approved a waiver of Section 1-3-18 A (2), permitting the County to house more than two polling places in the same room for the General Election, 2006;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, THE GOVERNING BODY OF SANTA FE COUNTY, NEW MEXICO:


That the polling place for Precincts 22 and 28, previously located at the De Vargas Mall public atrium, 564 North Guadalupe Street, Santa Fe, New Mexico, shall be moved to the Fort Marcy Complex gymnasium located at 490 Bishops Lodge Road, Santa Fe, New Mexico.


