EMERGENCY / DISASTER DECLARATION
SOUTHERN SANTA FE COUNTY

WHEREAS, Southern Santa Fe County has suffered severe damage caused by the snowstorms throughout the month of January, 2007;

WHEREAS, extensive damage was caused to Southern Santa Fe County by these storms and to the residents of that area;

WHEREAS, the damage has resulted in undue human suffering and hardship and threatens the safety, health, welfare, and well-being of citizens and economic functioning of Southern Santa Fe County;

WHEREAS, numerous roads are impassible and snowdrifts as high as twelve feet exist in areas of Southern Santa Fe County, and numerous citizens are therefore unable to access properties and residences;


WHEREAS, an unknown number of citizens may remain trapped in their residences since the most recent snowfall; and

WHEREAS, emergency snow removal is necessary to remedy the situation and abate the crisis.

NOW, THEREFORE I, by virtue of the authority provided by Santa Fe County Ordinances and by the New Mexico Civil Emergency Preparedness Act (NMSA 1978, Sections 12-10-01 to 12-10-11), do hereby declare Southern Santa Fe County to be an Emergency / Disaster area for the purpose of exercising necessary emergency powers and expenditure of available resources, and requesting aid, assistance, and relief programs and funds from the State of New Mexico. This declaration shall become effective when executed and shall be effective for ten (10) days, but may be terminated earlier if the County Manager informs the Board of County Commission that the emergency conditions have abated.

PASSED, APPROVED and ADOPTED this 5th DAY OF FEBRUARY, 2007.
