**A RESOLUTION APPROVING THE INCLUSION OF COUNTY-OWNED PROPERTY  
WITHIN THE CERRILLOS HILLS STATE PARK IN THE FEDERAL LAND WATER  
AND CONSERVATION FUND**

WHEREAS, the County of Santa Fe acquired the Cerrillos Hills Open Space property in 2000, to protect and manage significant natural and cultural resources and for the benefit and enjoyment of County residents; and

WHEREAS and the County of Santa Fe and the New Mexico Energy, Minerals, and Natural Resources Department/State Parks Division ("EMNRD") entered into a Joint Powers Agreement (JPA) on September 1, 2009, that provides for the establishment of Cerrillos Hills State Park on this County-owned property, and other State owned lands in the Village of Cerrillos; and

WHEREAS, the JPA states the County and EMNRD desire to form a long-term relationship in the management of this property and provides for the management and operation of Cerrillos Hills State Park by EMNRD; and

WHEREAS, the JPA specifies that EMNRD shall construct a visitor center and administrative office for the State Park, which includes multi-use community space available to the County for administrative and public education purposes; and

WHEREAS, EMNRD can access the federal Land and Water Conservation Fund (LWCF) for the construction of the visitor center, which will match funds for the visitor center's construction contributed by EMNRD; and

WHEREAS, accessing federal funds for a LWCF project subjects the property to Section 6(f)(3) of the LWCF Act, which specifies that such property shall not be developed or converted to non-park and recreation uses without federal approval; and


WHEREAS, placing County-owned property and State-owned property within Cerrillos Hills State Park in the LWCF program will benefit the park, the County, and EMNRD by gaining access to matching funds that will support the visitor center project, and will not impact the status of the County-owned property, as this property was not intended for development; and

WHEREAS, EMNRD intends to place its state-owned property within the park into the LWCF program if the County does likewise;


NOW THEREFORE, the County of Santa Fe approves and endorses the inclusion of County-owned property within Cerrillos Hills State Park in the federal Land and Water Conservation Fund program.




