**A RESOLUTION REQUESTING PARTICIPATION IN THE 2010/2011 LOCAL GOVERNMENT ROAD FUND PROGRAM , SP FUNDING, ROAD IMPROVEMENTS ON COUNTY ROADS VERANO LOOP, VERANO COURT, VERANO DRIVE, VERANO LANE, VERANO PLACE AND VERANO WAY, NEW MEXICO DEPARTMENT OF TRANSPORTATION**

**WHEREAS**, the Board of County Commissioners (hereafter referred to as “the Board”) desires to utilize funding made available through an application submitted to the New Mexico Department of Transportation’s LGRF (Local Government Road Fund) Program for various County road improvement projects: and

**WHEREAS**, upon approval of the application submitted to the New Mexico Department of Transportation (hereafter referred to as “the Department”) funding will be received in the form of Cooperative Agreement - SP: and

**WHEREAS**, the Department requires that the Board provide a Resolution requesting funding and attach a detailed project breakdown per funding source; and

**WHEREAS**, a detailed project breakdown, together with the agreed County match, is set forth in Exhibit “A” herein for County Roads Verano Court, Verano Drive, Verano Lane, Verano Loop, Verano Place and Verano Way Road Improvement projects,

**NOW THEREFORE**, the Board of County Commissioners hereby requests funding for the project set forth in Exhibit “A” for the 2010/2011 New Mexico Department of Transportations LGRF Program based on the requested project amount and quantities listed therein.







Location: County Roads Verano Loop, Verano Court, Verano Lane, Verano Drive, Verano Place and Verano Way.

Verano Loop Starting Termini: 2.20 miles northwest  
Ending Termini; .06 mile to Avenida Del Monte Alto.

Verano Court Starting termini; Verano Loop  
Ending Termini; Northeast 0.07 mile.

Verano Lane Starting Termini; Verano Loop north 0.15 mile.  
Ending Termini; Verano Loop

Verano Drive Starting Termini; Verano Loop north 0.16 miles  
Ending Termini; Verano Loop.

Verano Place Starting Termini; Verano Loop.  
Ending Termini; North 0.07 mile.

Verano Way beginning termini; Verano Loop.  
Ending Termini; North 0.09 mile.

Scope of Work: Reclaim existing chip seal and replace with new chip seal surface.

Project Estimate: Total Estimated Construction Cost \$94,528.46
