**A RESOLUTION OF SUPPORT FOR COUNTY PARTICIPATION IN THE 2009-2010 NEW MEXICO DEPARTMENT OF TRANSPORTATION LOCAL GOVERNMENT ROAD FUND COOPERATIVE AGREEMENT FOR PAVEMENT REHABILITATION AND IMPROVEMENTS OF COUNTY ROAD 17 (MARTIN ROAD) IN SANTA FE COUNTY, NEW MEXICO UNDER THE SCHOOL BUS ROUTE PROGRAM PROJECT NO. SB-7789(982)10**

**WHEREAS**, pursuant to section 67-3-28.2, NMSA 1978, assistance for local road construction and repair is available through the New Mexico Department of Transportation for the Local Government Fund; and

**WHEREAS**, the County of Santa Fe applied for funding from the School Bus Route Program for pavement rehabilitation and improvements of CR17 (Martin Road) in Santa Fe County, New Mexico (the "Project"). The total project cost (including 25% county participation) is \$77,876.00; and

**WHEREAS**, the County of Santa Fe has agreed with the State of New Mexico to utilize awarded funds from the School Bus Route Program for pavement rehabilitation and improvements of CR17 (Martin Road); and

**WHEREAS**, to obtain funds from Local Government Road Fund, a local government must agree to provide matching funds pursuant to Section 67-3-32, NMSA 1978; and

**WHEREAS**, the Board of County Commissioners of Santa Fe County supports the Project and will provide 25% of the funds for the Project as required under the School Bus Route Program.


**NOW THEREFORE, BE IT RESOLVED** that the Board of County Commissioners agree to execute the School Bus Route Cooperative Agreement to obtain funds for pavement rehabilitation and improvements of CR17 (Martin Road) in Santa Fe County, New Mexico, and supports the pavement rehabilitation and improvements of CR17 (Martin Road) in Santa Fe County, New Mexico, and will provide matching funds for this Project in the amount of \$19,469.00.




