## A CITY/COUNTY JOINT ORDINANCE

PROVIDING FOR THE EXTENSION OF THE SERVICE AREA BOUNDARIES  
OF THE REGIONAL WATER SYSTEM.

BE IT ORDAINED BY THE GOVERNING BODIES OF THE CITY AND  
COUNTY OF SANTA FE:

Section 1. SHORT TITLE. This Ordinance shall be known  
as the City/County Joint Water Boundary Extension Ordinance  
No. 11.

Section 2. PURPOSE. The purpose of this Ordinance is  
to provide for approval of the extension of regional water  
system boundaries, pursuant to Article 4, Paragraph B of the  
City of Santa Fe and Public Service Company of New Mexico  
Water Franchise Ordinance No. 1979-40, to include the  
geographic area described in Section 4 of this Ordinance.

Section 3. DEFINITIONS. The terms "Regional Water  
System", "PNM" and "Service Area Boundaries" utilized in  
this ordinance shall have the same meaning here as they do  
in the Joint Metropolitan Water Board Ordinance No. 1980-18.

Section 4. AUTHORIZATION OF SERVICE AREA EXTENSION.  
The City and County of Santa Fe do hereby authorize the  
extension of the service area boundaries of the regional  
water system as recommended by the Metropolitan Water Board  
at its meeting of April 18, 1989.

The service area extension shall be limited to the 652537 property described and as shown on the plat of survey for a portion of Colony Materials Inc., prepared by Gary E. Dawson, NMPLS #7014, attached as Exhibit A.


