

**AMENDMENT NO. 3 TO  
PROFESSIONAL SERVICES AGREEMENT  
BETWEEN SANTA FE COUNTY  
AND ACCOUNTABLE HEALTHCARE STAFFING, INC.  
FOR TEMPORARY NURSING SERVICES**

**THIS AMENDMENT** is made and entered into this 30<sup>th</sup> day of January 2015, by and between **Santa Fe County**, hereinafter referred to as “the County”, a New Mexico political subdivision, and **Accountable Healthcare Staffing, Inc.**, hereafter referred to as “the Contractor.”

**WHEREAS**, in accordance with NMSA 1978, Section 13-1-112, the County issued Request for Proposals (RFP) No. 2012-0131-CORR/PL for Temporary Nursing Services for the Santa Fe County Corrections Department; and

**WHEREAS**, Contractor has been providing temporary nursing services throughout 2012, 2013 and 2014 and the County needs Contractor to continue providing these services; and

**WHEREAS**, pursuant to Amendment No. 1 to Agreement No. 2012-0131C-CORR/PL, the term of the Agreement was extended to February 28, 2014 and Amendment No. 2 to Agreement No. 2012-0131C-CORR/PL the term of the Agreement was extended to February 28, 2015 and according to Section 4 (Effective Date and Term) of the Agreement, the County has the option to extend the term of the Agreement for one (1) year to February 28, 2016; and

**WHEREAS**, by this Amendment No. 3, the term of the Agreement will be extended one (1) year on the same terms and conditions as stated in the initial agreement.

**NOW THEREFORE**, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:


1. Paragraph 4 of Agreement No. 2012-0131C-CORR/PL is amended by inserting the following provision as subparagraph “4.3”:

4.3 Pursuant to Amendment No. 3, the term of this Agreement is extended to February 28, 2016, unless earlier terminated pursuant to Section 5 (Termination), or Section 6 (Appropriations and Authorization), of this Agreement.

2. All other provisions of Agreement No. 2012-0131C-CORR/PL including the rates stated in Exhibit A to the Agreement not specifically amended or modified by Amendment Nos. 1, 2 and this Amendment No. 3 shall remain in full force and effect.
