

AMENDMENT TO SUB-GRANT AGREEMENT

NMED GRANT/LOAN NUMBER: ARRA BRLF 01 - Santa Fe County Judicial Complex

THIS AMENDMENT is made and entered into as of this 8th day of March, 2012 by and between the New Mexico Environment Department of the State of New Mexico, hereinafter referred to as "NMED", and the Santa Fe County, hereinafter referred to as the "Grantee".

It is mutually agreed between the parties that the following provisions of the above-referenced sub-grant agreement are amended as follows:

AMENDMENT No. 1

SECTION III, GRANT TERM, is hereby amended to read as follows:

NMED agrees to grant funds to the Grantee to pay for approved costs to plan and implement the Project, in an amount not to exceed: Three Hundred Eighty-Two Thousand Five Hundred Sixty-Two Dollars and No Cents (\$382,562) ("Grant Amount") during the project upon the terms and conditions set forth in this Agreement. Provided the Grantee complies with the conditions and the requirements below, the grant amount will be available for a period of not to exceed eighteen months from the date of this Agreement.

This sub-grant agreement as amended shall become effective when the NMED and the Grantee have executed this agreement on the dates set forth by their respective names.

All other articles of this agreement remain the same.
