

**SANTA FE COUNTY
AMENDMENT NO. 1 TO
PROFESSIONAL SERVICES AGREEMENT BETWEEN
SANTA FE COUNTY AND MARY LOUISE ROMERO
TO PROVIDE EDUCATIONAL SERVICES TO TEEN COURT**

THIS AMENDMENT is made and entered into as of this 7 day of June, 2012, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and Mary Louise Romero, a sole proprietor with principal address of 1601 ½ Young Street, Santa Fe, NM 87505 (hereinafter referred to as "the Contractor").

WHEREAS, pursuant to a determination as a small purchase, on June 9, 2010 the County entered into Contract No. 2010-0405-CSD/TRV with Contractor to provide monthly educational presentations to participants of Teen Court;

WHEREAS, the term of Contract No. 2010-0405-CSD/TRV is four (4) years and the initial compensation beginning in FY 2011 was a not-to-exceed amount of \$2,200 exclusive of grt;

WHEREAS, the County wishes to continue the Contractor's services into fiscal year 2013, and amend the Contract to increase the compensation for the Contractor's services in FY 2013;

WHEREAS, pursuant to Paragraph 17, the parties may amend Contract No. 2010-0405-CSD/TRV by an instrument in writing executed by the parties;

WHEREAS, the increase in compensation by this Amendment No. 1 results in a total not-to-exceed amount of \$4,400.00 exclusive of grt.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. Paragraph 2 (Compensation) of Contract No. 2010-0405-CSD/TRV, is amended by inserting a new subparagraph A.3) to read as follows:
 - 3) By Amendment No. 1 to this Contract, the County shall pay Contractor for services provided in FY 2013 at \$50 per hour for a continuation of the educational services stated in 1) and 2) above. In no event shall the total compensation paid to Contractor for services rendered beginning in FY 2013 exceed \$2,374.63 inclusive of gross receipts tax.
2. All other provisions of Contract No. 201-0405-CSD/TRV not specifically amended or modified by this Amendment No. 1, remain in full force and effect.

WHEREAS, the County wishes to continue the Contractor's services into fiscal year 2013, and amend the Contract to increase the compensation for the Contractor's services in FY 2013;

WHEREAS, pursuant to Paragraph 17, the parties may amend Contract No. 2010-0405-CSD/TRV by an instrument in writing executed by the parties;

WHEREAS, the increase in compensation by this Amendment No. 1 results in a total not-to-exceed amount of \$4,400.00 exclusive of grt.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. Paragraph 2 (Compensation) of Contract No. 2010-0405-CSD/TRV, is amended by inserting a new subparagraph A.3) to read as follows:
 - 3) By Amendment No. 1 to this Contract, the County shall pay Contractor for services provided in FY 2013 at \$50 per hour for a continuation of the educational services stated in 1) and 2) above. In no event shall the total compensation paid to Contractor for services rendered beginning in FY 2013 exceed \$2,374.63 inclusive of gross receipts tax.
2. All other provisions of Contract No. 201-0405-CSD/TRV not specifically amended or modified by this Amendment No. 1, remain in full force and effect.




