

**AMENDMENT NO. 3 TO
SANTA FE COUNTY SERVICES AGREEMENT
WITH TRINITY SERVICES I, LLC TO PROVIDE FOOD SERVICES AND
COMMISSARY OPERATIONS AT THE SANTA FE COUNTY
CORRECTIONS DEPARTMENT**

THIS AMENDMENT is made and entered into as of the 15th day of August, 2014 by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter the "County") and **Trinity Services I, LLC**, a Florida limited liability company with a principal address located at 477 Commerce Boulevard, Oldsmar, FL 34677.

WHEREAS, pursuant to NMSA 1978, Sections 13-1-112 and 13-1-117, competitive, sealed proposals were solicited via a formal request for proposals, RFP No. 2010-0388-CORR/TRV, for the provision of food services and commissary operations;

WHEREAS, Canteen Correctional Services, was selected as the most qualified offeror and the County and Canteen entered into Agreement No. 2010-0388-CORR/TRV to provide for Canteen's provision of food services and commissary operations;

WHEREAS, Agreement 2010-0388-CORR/TRV was amended when Trinity Services I, LLC agreed to assume all of the rights and obligations of Canteen under Agreement No. 2010-0388. The Contractor under Agreement No. 2010-0388-CORR/TRV was changed from Canteen Correctional Services to Trinity Services I, LLC;

WHEREAS, Agreement No. 2010-0388-CORR/TRV will expire August 31, 2014;

WHEREAS, the County will conduct a new procurement for food services and commissary operations and desires to amend Agreement No. 2010-0388-CORR/TRV such that Trinity Services will continue to provide the services on a month-to-month basis until a new contractor is procured by the County;

WHEREAS, Article 16 of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties;

WHEREAS, the parties wish to enter into this Amendment No. 3 to amend the term of Agreement No. 2010-0288-CORR/TRV to commence on a month-to-month basis beginning September 1, 2014, as stated herein.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. By this Amendment No. 3, effective September 1, 2014 the County and Contractor will continue to perform under the terms and conditions of Agreement No. 2010-0388-CORR/TRV, as amended, on a month-to-month basis and this Agreement will expire November 30, 2014 unless earlier terminated by the County. The County may elect to terminate this month-to-month Agreement prior to November 30, 2014 by providing Contractor not less than thirty (30) days prior written notice.


- 2. Upon commencement on a month-to-month basis of Contractor's performance of the duties and obligations under Agreement No. 2010-0388-CORR/TRV, County shall pay compensation to Contractor for meal services based on the following scale and pricing:

201 – 250	\$1.175
251 – 300	\$1.164
301 – 350	\$1.109

476 – 525	\$1.012
526 – 575	\$0.9916
576 – 625	\$0.9714
626 – 675	\$0.9580

- 3. Except as stated in Paragraph 1 and 2 above, all other provisions of Agreement No. 2010-0388-CORR/TRV not specifically amended by this Amendment No. 3, shall remain in full force and effect.




