

**AMENDMENT NO. 1  
TO PRICE AGREEMENT NO. 2014-0198-A-PW/MS**

This amendment is made and entered into this 16 day of February, 2016, by and between **Santa Fe County**, (hereinafter referred to as the "County"), a New Mexico political subdivision, and **General Parts Distribution, LLC, dba Carquest Auto Parts**, 1209 Siler Road, Santa Fe, New Mexico 87505.

**WHEREAS**, the County and General Parts Distribution, LLC, *dba* Carquest Auto Parts entered into Price Agreement No. 2014-0198-A-PW/MS (Agreement) dated April 18, 2014, to provide an indefinite quantity of automotive parts, equipment, tires and services for the County; and

**WHEREAS**, Advance Stores Company, Inc. is the parent company of General Parts Distribution, LLC, *dba* Carquest Auto Parts, and Advance Auto Parts, Inc. *dba* Advance Auto Parts; and

**WHEREAS**, in 2014, Advance Auto Parts, Inc. acquired General Parts Distribution, LLC, *dba* Carquest, and is now doing business as Advance Auto Parts; and

**WHEREAS**, according to Article 7 of the Agreement, the Agreement may be amended in writing upon mutual agreement of the parties; and

**WHEREAS**, the parties wish to amend the Agreement to identify the name of the contractor under the Agreement after Advance Auto Part's acquisition of General Parts Distribution *dba* Carquest Auto Parts.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. In the introductory paragraph of the Agreement, the reference to **General Parts Distribution, LLC, dba Carquest Auto Parts** is deleted and replace with **Advance Auto Parts, Inc. dba Advance Auto Parts**.
2. In Article 23 (Notices) of the Agreement, the reference to Carquest Auto Parts is deleted and replace with Advance Auto Parts.
3. All other provisions and terms and conditions of the Agreement including the costs listed on the Revised Bid Sheet attached and referenced as Attachment A, not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.


