

**SANTA FE COUNTY  
AMENDMENT NO. 1 TO THE AGREEMENT  
WITH COATES TREE SERVICE, INC.  
TO PROVIDE TREE TRIMMING, TREE REMOVAL & MOWING SERVICES**

**THIS AMENDMENT** is made and entered into this 30<sup>th</sup> day of January 2015, by and between **SANTA FE COUNTY**, hereinafter referred to as “the County”, a New Mexico political subdivision, and **COATES TREE SERVICE, INC.**, hereinafter referred to as “the Contractor.”

**WHEREAS**, pursuant to NMSA 1978, Sections 13-1-112 and 13-1-117 of the Procurement Code, an Invitation to Bid (IFB) was issued for tree trimming, tree removal and mowing services; and

**WHEREAS**, on December 31, 2013 the County and Contractor entered into Agreement No. 2014-0146-C-PW/PL to provide these services for a term of one (1) year; and

**WHEREAS**, Article 15, “NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED,” of Agreement No. 2014-0146-C-PW/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

**WHEREAS**, Article 3, “EFFECTIVE DATE AND TERM”, the County has the option to extend the term for one (1) year; and

**WHEREAS**, the parties desire to enter into this Amendment No. 1 to extend the term for one (1) year to December 31, 2015.

**NOW THEREFORE**, both parties agree as follows:

1. ARTICLE 3. “EFFECTIVE DATE AND TERM” a new subparagraph “3.a” is inserted to read as follows:
  - a. By Amendment No. 1, the County notifies Contractor and exercises the County’s option to extend the term of this Agreement for one (1) year from December 31, 2014 to December 31, 2015 on the same terms and conditions as stated in Agreement No. 2014-0146-C-PW/PL.
2. All other provisions of Agreement No. 2014-0146-C-PW/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
