

**AMENDMENT NO. 1
TO PRICE AGREEMENT BETWEEN SANTA FE COUNTY
AND GALL'S, LLC**

THIS AMENDMENT is made and entered into this 3rd day of February 2015, by and between **SANTA FE COUNTY**, (hereinafter referred to as "County"), a New Mexico political subdivision, and **GALLS, LLC**, (hereafter referred to as "the Contractor"), a New Mexico corporation.

WHEREAS, in accordance with NMSA 1978 Sections 13-1-102 and 113-1-110, the County issued Invitation for Bid (IFB) No. 2013-0320-CORR/PL for the purchase of uniforms for the Corrections Department; and

WHEREAS, on June 17, 2013 the County and Contractor entered into Agreement No. 2013-0320-CORR/PL for these services for a term of one year; and

WHEREAS, Section 7, "AMENDMENT" of Agreement No. 2013-0320-CORR/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

WHEREAS, the County wishes to amend the Price Sheet Exhibit "A" of Agreement No. 2013-0320-CORR/PL to add additional large uniform sizes and women's boot sizes to the items to be provided by the Contractor under this Price Agreement; and

WHEREAS, both parties desire to enter into Amendment No.1.

NOW THEREFORE, both parties agree as follows:

1. Agreement No. 2013-0320-CORR/PL is amended by deleting Exhibit A in its entirety and replacing with the attached Exhibit A (Revised).
2. All other provisions of Agreement No. 2013-0320-CORR/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.




