

**SANTA FE COUNTY  
AMENDMENT NO. 1 TO THE AGREEMENT  
WITH LLOYD & ASSOCIATES ARCHITECTS  
FOR PROFESSIONAL ARCHITECTURAL SERVICES**

**THIS AMENDMENT** is made this 6<sup>th</sup> day of May 2015, by and between **Santa Fe County**, hereinafter referred to as “the County”, a New Mexico political subdivision, and **Lloyd & Associates Architects**, hereafter referred to as “the Contractor.”

**WHEREAS**, in accordance with NMSA 1978 Sections 13-1-125 (B), the County issued Letter of Interest (LOI) No. 2014-0026-FD/PL for architectural design services for the Hondo Fire Station No. 1 apparatus bay addition and roof upgrades; and

**WHEREAS**, on February 2, 2014 the County and Contractor entered into Agreement No. 2014-0026-FD/PL to provide these services for a term of one (1) year; and

**WHEREAS**, Part B, Article 12, “NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED,” of Agreement No. 2014-0026-FD/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

**WHEREAS**, the parties desire to enter into this Amendment No. 1 to extend the term for another year to February 2, 2016.

**NOW THEREFORE**, both parties agree as follows:

1. ARTICLE 2. “EFFECTIVE DATE AND TERM” a new subparagraph “2.a” is inserted to read as follow:
  - a. By Amendment No. 1, the County notifies Contractor and exercises the County’s option to extend the term of this Agreement for one (1) year from February 2, 2015 to February 2, 2016, on the same terms and conditions as stated in Agreement No. 2014-0026-FD/PL.
2. The effective date of this first option to extend the term of this Agreement under this Amendment No. 1 shall be February 2, 2015.
3. All other provisions of Agreement No. 2014-0026-FD/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.

**IN WITNESS WHEREOF**, the parties have duly executed this Amendment No. 1 to Agreement No. 2014-0026-FD/PL effective as of February 2, 2015.
