

**AMENDMENT NO. 1 TO AGREEMENT
BETWEEN SANTA FE COUNTY
AND THE CITY OF ESPANOLA**

THIS AMENDMENT is made and entered into this 23rd day of October 2014, by and between **Santa Fe County**, hereinafter referred to as "County", a New Mexico political subdivision, and the **City of Espanola**, (hereafter referred to as the "City"), a New Mexico "municipality" or "local public body", located at 405 N. Paseo de Oate, Espanola, New Mexico 87532.

WHEREAS, on November 4, 2013 the County and City entered into Memorandum of Understanding No. 2014-0091-HHSD/GG to provide residents and the public of Santa Fe County with programs that promote reading and literacy, and is committed to improving opportunities for community members to enhance their cultural and leisure activities; and

WHEREAS, Article 11, "AMENDMENT," of Agreement No. 2014-0091-HHSD/GG allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

WHEREAS, the County wishes to extend the term of the Memorandum of Understanding to June 30, 2015 and increase the compensation by \$30,000 for a total amount of \$55,000.00; and

WHEREAS, both parties desire to enter into this Amendment No. 1.

NOW THEREFORE both parties agree as follows.

1. ARTICLE 2. "COMPENSATION" a new subparagraph "A.1.a" is inserted to read as follows:

By Amendment No. 1, the County exercised its first option to extend this Agreement from November 4, 2014 to June 30, 2015. The total amount payable to the City for the term November 4, 2014 to June 30, 2015, exclusive of NM gross receipts tax, shall not exceed thirty thousand (\$30,000.00). The total amount payable to the City under this Agreement, as amended, shall not exceed fifty-five thousand dollars (\$55,000.00), exclusive of NM gross receipts tax.

2. ARTICLE 3. "EFFECTIVE DATE AND TERM" a new subparagraph "3.a" is inserted to read as follows:

a. By Amendment No. 1, the County notifies City and exercised the County's first option to extend the term of this Agreement. Amendment No. 1 extends the term of the Agreement from November 4, 2014 to June 30, 2015 on the same terms and conditions as stated herein and a \$30,000.00 increase in compensation.

3. All other provisions of Agreement No. 2014-0091-HHSD/GG not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
