

**SANTA FE COUNTY  
AMENDMENT NO. 1 TO THE AGREEMENT  
WITH MORRIS SURVEYING ENGINEERING, LLC  
TO PROVIDE ENGINEERING DESIGN SERVICES**

**THIS AMENDMENT** is made and entered into this 17<sup>th</sup> day of December 2013, by and between **Santa Fe County**, hereinafter referred to as "County", a New Mexico political subdivision, and **Morris Surveying Engineering, LLC** hereafter referred to as "the Contractor."

**WHEREAS**, in accordance with NMSA 1978 Section 13-1-120 through 13-1-124, the County issued Request for Qualifications (RFQ) No. 2013-0177-PW/PL for engineering services to design a parking lot for the Cundiyo Community Center;

**WHEREAS**, on January 30, 2013 the County and Contractor entered into Agreement No. 2013-0177-PW/PL to provide these services for a term of one (1) year;

**WHEREAS**, Article 15, "NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED," of Agreement No. 2013-0117-PW/PL allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto;

**WHEREAS**, the County wishes to extend the term of the Agreement for another year to January 30, 2015.

**WHEREAS**, both parties desire to enter into Amendment No. 1.

**NOW THEREFORE**, both parties agree as follows:

1. ARTICLE 3. "EFFECTIVE DATE AND TERM" a new subparagraph "3.a" is inserted to read as follows:
  - a. By Amendment No. 1, the County notifies Contractor and exercised the County's first option to extend the term of this Agreement for one (1) year from January 30, 2014 to January 30, 2015 on the same terms and conditions as stated in Agreement No. 2013-0177-PW/PL.
2. All other provisions of Agreement No. 2013-0177-PW/PL not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
