

**AMENDMENT NO. 1
TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN
SANTA FE COUNTY AND THE REGENTS OF THE UNIVERSITY OF NEW MEXICO
FOR A FORECAST STUDY AND REPORT REGARDING EMPLOYMENT
PROJECTIONS**

THIS AMENDMENT is made and entered into this 1st day of Apr. 1 2014, between the **Regents of the University of New Mexico**, a constitutionally created entity of the State of New Mexico and an Hispanic serving institution of higher education (“**UNM**”) and **Santa Fe County** (“**County**”) a political subdivision of the State of New Mexico located in Santa Fe, New Mexico, and collectively referred to as the “**Parties**”.

WHEREAS, on February 27, 2014 the Parties entered into Agreement No. 2014-0114-GM/GG to provide a study and report regarding employment forecast for the County and the study area geographies;

WHEREAS, Article 12, “MODIFICATIONS,” of Agreement No. 2014-0114-GM/GG allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto;

WHEREAS, the Parties wish to amend the Agreement to correct the error in the omission of Article 4, “TERM AND TERMINATION” and add this provision to clarify the term of the Agreement to include language for the effective date, term and conditions for termination of the Agreement;

WHEREAS, both parties desire to enter into Amendment No. 1.

NOW THEREFORE, both parties agree as follows:

1. Insert Article No. 4 “**TERM AND TERMINATION**” to read as follows:

4. TERM AND TERMINATION

This Agreement is effective as of February 27, 2014 and shall terminate one (1) year later unless earlier terminated pursuant to this Section or Section 3 “**APPROPRIATIONS AND AUTHORIZATIONS**” of the Agreement.

The period of the agreement may be extended for one (1) additional year by the mutual written agreement of both Parties. This Agreement may be terminated by either of the Parties hereto upon written notice delivered to the County party not less than thirty (30) days prior to intended date of termination, provided, however, that UNM may terminate this Agreement upon five (5) days notice if any payment due from County is not received before or upon the date due. In the event County terminates this Agreement without cause or for any reason, UNM shall be permitted to complete any deliverables then in process and County shall pay UNM for all costs incurred through the date of termination, including all non-cancelable

obligations, even though the obligations may extend beyond the termination date. Termination will not affect the Parties' rights and obligations accrued prior to termination.

- 2. All other provisions of Agreement No. 2014-0114-GM/GG not specifically amended or modified by this Amendment No. 1 shall remain in full force and effect.
