

**AMENDMENT NO. 1 TO
PROFESSIONAL SERVICES AGREEMENT BETWEEN
SANTA FE COUNTY AND TYLER TECHNOLOGIES TO
PROVIDE DATA COLLECTION SERVICES**

THIS AMENDMENT is made and entered into on the 15th day of February, 2013, by and between Santa Fe County (hereinafter referred to as the "County") and Tyler Technologies, 3199 Klepinger Road, Dayton, Ohio 45406 (hereinafter "Contractor").

WHEREAS, pursuant to the Procurement Code, 13-1-28 et. seq. NMSA 1978, and the provisions of the Santa Fe Purchasing Regulations, Professional Services Agreement No. 2012-0001-AS/MS was procured and entered into with Contractor;

WHEREAS, Contractor's services consists of data collection for the Office of the County Assessor;

WHEREAS, Contractor has been performing services throughout 2012 and the County needs Contractor to continue providing services to complete the County's data collection project;

WHEREAS, according to Section 3, Agreement No 2012-0001-AS/MS will expire February 28, 2013 which is subject to a two (2) year extension in one (1) year increments;

WHEREAS, according to Section 15 (Amendment) the Agreement may be amended by an instrument in writing executed by the parties;

WHEREAS, the parties wish to amend the Agreement to extend the term one (1) year to February 28, 2014.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:


1. Paragraph 3 of Agreement No. 2012-0001-AS/MS is amended by adding the following provision as subparagraph 3.1:

3.1 Pursuant to Amendment No. 1, the term of this Agreement is extended one (1) year. This Agreement shall terminate February 28, 2014, unless earlier terminated pursuant to Section 5 (Termination), or Section 6 (Appropriations and Authorizations), of this Agreement.

3. All other provisions of Agreement No. 2012-0001-AS/MS not amended or modified by this Amendment No. 1, remain in full force and effect.






