

**AMENDMENT NO. 1
TO PROFESSIONAL SERVICES AGREEMENT BETWEEN
SANTA FE COUNTY AND KSWV RADIO**

THIS AMENDMENT is made and entered into as of this ___ day of _____, 2011, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and **KSWV Radio**, hereinafter referred to as "Contractor."

WHEREAS, Santa Fe County and Contractor entered into Professional Services Agreement No. 29-0214-MG/VO pertaining to radio broadcast services to be provided by Contractor;

WHEREAS, Agreement 29-0214-MG/VO is for a term of four years in which the parties agreed that Contractor would be compensated specific monthly payments in Year One, Year Two, Year Three and Year Four for a not-to-exceed sum of \$176,674.98 over the term of the Agreement;

WHEREAS, the parties agree that the monthly compensation for Year Three and Four of the term should be amended to be \$3,605.78 per month for each of Year Three and Year Four;

WHEREAS, Article 17 of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties;


WHEREAS, with this Amendment No. 1 the total not-to-exceed sum will be \$171,413.28 for the remaining term of the Agreement.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. Paragraph 2 (Compensation and Invoicing) is amended by deleting the reference to "\$176,674.98" and replacing it with "\$171,413.28."
2. Paragraph 2 (Compensation and Invoicing), subparagraph C is amended by deleting "Three Thousand Seven Hundred and Fifty dollars and two/cents (\$3,750.02)" and replacing it with "Three Thousand Six Hundred Five Dollars and Seventy-Eight cents (\$3,605.78)."
3. Paragraph 2 (Compensation and Invoicing), subparagraph D is amended by deleting "Three Thousand Nine Hundred and two/cents (\$3,900.02)" and replacing it with "Three Thousand Six Hundred Five Dollars and Seventy-Eight cents (\$3,605.78)."
4. All other provisions of Professional Services Agreement No. 29-0214-MG/VO not specifically amended or modified by this Amendment No. 1, remain in full force and effect.


