

**SANTA FE COUNTY
AMENDMENT NO. 2
TO THE AGREEMENT WITH LA FAMILIA MEDICAL CENTER FOR THE
DELIVERY OF MEDICATION ASSISTED TREATMENT SERVICES**

THIS AMENDMENT is made and entered into this 4th day of August 2014, by and between **Santa Fe County**, (hereinafter referred to as “County”), and **La Familia Medical Center**, (hereafter referred to as “the Contractor”).

WHEREAS, the County and Contractor entered into Agreement No. 2014-0035-HHS/PL on September 12, 2013 to provide for Contractor’s delivery of medication assisted treatment services and outreach programs;

WHEREAS, Article 15, “NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED,” of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto;

WHEREAS, by Amendment No. 1 the Agreement was amended to allow the Contractor to expand its public awareness/outreach campaign efforts and increase the Contractor’s compensation by \$13,000;

WHEREAS, by this Amendment No. 2 the County wishes to extend the term of the Agreement to September 12, 2015 and increase the Contractor’s compensation by \$50,000.00 for a total not-to-exceed amount of \$158,000;

WHEREAS, both parties desire to enter into this Amendment No. 2.


NOW THEREFORE, it is mutually agreed between the parties that Agreement No. 2014-0035-HHS/PL be amended as follows:

1. ARTICLE 2.A.3). (Compensation, Invoicing and Set-Off) is amended by inserting subparagraph “b” to read as follows:
 - b. Pursuant to Amendment No. 2, the Contractor’s compensation is increased by fifty thousand dollars (\$50,000.00). The total amount payable to the Contractor for the term of this Agreement, inclusive of gross receipts tax, shall not exceed One Hundred Fifty-Eight Thousand Dollars (\$158,000.00).
2. ARTICLE 3. (Effective Date and Term) is amended by inserting subparagraph “a” to read as follows:
 - a. Pursuant to Amendment No. 2, the County notifies Contractor and exercised the County’s first option to extend the term of this Agreement for one (1) year from September 12, 2014 to September 12, 2015 on the same terms and conditions as stated herein and a \$50,000.00 increase in compensation.

3. All other provisions of Agreement No. 2014-0035-HHS/PL not specifically amended or modified by this Amendment No. 2 shall remain in full force and effect.






