

**AMENDMENT NO. 2  
TO PROFESSIONAL SERVICES AGREEMENT  
BETWEEN JUSTICE BENEFITS, INC.  
FOR CONSULTING SERVICES FOR THE ADULT DETENTION FACILITY**

**THIS AMENDMENT** is made and entered into this 12<sup>th</sup> day of June, 2015 by and between **Santa Fe County** (hereinafter "County"), a political subdivision of the State of New Mexico, and **Justice Benefits, Inc.** (a Texas Corporation) doing business as a general partner of Unificare, LTD., whose primary place of business is 2010 Valley View Lane, Suite 300, Dallas, Texas, hereinafter referred to as the "Contractor."

**WHEREAS**, the County and Contractor entered into Agreement No. 2013-0308-CORR/MS on June 18, 2013 to provide for Contractor's provision of consultant services to assist the County in filing claims for Federal Financial Participation (FFP) reimbursements for activities that meet FFP objectives; and

**WHEREAS**, according to Section 16 (No Oral Modification; Written Amendments Required), all amendments and modifications to the Agreement are required to be in writing and signed by the parties; and

**WHEREAS**, by Amendment No. 1 to this Agreement, the County exercised its first option to extend the term of this Agreement from June 18, 2014 to June 18, 2015; and

**WHEREAS**, the parties wish to amend Agreement No. 2013-0308-CORR/MS to extend the term from June 18, 2015 to June 18, 2016.

**NOW THEREFORE** in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

1. Section 5 (Effective Date; Contract Time) of Agreement No. 2013-0308-CORR/MS is amended by inserting a subparagraph "b" to read as follows:

b) By Amendment No. 2 to this Agreement, the County exercised its second option to extend the term of this Agreement. The term of this Agreement is extended from June 18, 2015 to June 18, 2016.

2. All other provisions of Agreement No. 2013-0308-CORR/MS not specifically amended or modified by Amendment No. 1 and this Amendment No. 2 shall remain in full force and effect.
