

**AMENDMENT NO. 2 TO
SERVICES AGREEMENT
WITH NEW MEXICO FIRE SUPPORT SERVICES
TO PROVIDE DATA COLLECTION AND
ELECTRONIC RECORDS MANAGEMENT SERVICES**

THIS AMENDMENT is made and entered into as of the 18th day of September, 2012, by and between Santa Fe County, herein after "County," and New Mexico Fires Support Services, LLC, a New Mexico limited liability company, with a principal address located at 13170 Central SE, Suite B149, Albuquerque, NM 87123, hereinafter referred to as "the Contractor."

WHEREAS, pursuant to NMSA 1978, Section 13-1-112 and 13-117, competitive, sealed proposals were solicited via a formal request for proposals, RFP No. 2011-0004-FD/MS, for the provision of the services;

WHEREAS, based on the evaluation criteria established within the request for proposals for the purposes of determining the most qualified Offeror, the County has determined Contractor as the most responsive and highest rated Offeror;

WHEREAS, the County desires to engage the Contractor to render data collection and electronic records management services described in the RFP, and the Contractor is willing to render such services;

WHEREAS, the County requires these services and the Contractor is willing to provide these services and both parties wish to enter into this Agreement;

WHEREAS, Amendment No. 1 increased the compensation by \$22,470;


WHEREAS, by this Amendment No. 2, the parties wish to amend the Agreement to increase the compensation in the amount of \$14,000.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. Paragraph 2.A. of Agreement 2011-0004-FD/MS is amended by deleting the reference to "One Hundred Twenty Thousand, Four Hundred Seventy Dollars (\$120,470.00)" and replacing it with "One Hundred Thirty-Four Thousand, Four Hundred Seventy Dollars (\$134,470.00)."
2. All other provisions of Agreement No. 2011-0004-FD/MS not amended by Amendment No. 1 and this Amendment No.2 remain in full force and effect.


