

**AMENDMENT NO. 2  
PROFESSIONAL SERVICES AGREEMENT  
WITH APRYL MILLER  
TO PROVIDE COUNSELING SERVICES**

**THIS AMENDMENT** is made and entered into as of this 3<sup>rd</sup> day of September, 2015 by and between **Santa Fe County**, hereinafter referred to as "the County", a New Mexico political subdivision, and **Apryl Miller**, hereafter referred to as "the Contractor".

**WHEREAS**, on September 4, 2014, the County and the Contractor entered into Agreement No. 2015-0006-HH/MM for the Contractor's provision of individual and/or family counseling sessions for Teen Court participants; and

**WHEREAS**, by Amendment No.1, the County increased compensation by \$13,000.00; and

**WHEREAS**, Article 3 (Effective Date and Term) of the Agreements provides for a one year term and reserves to the County the option to extend the term of the Agreement in one year increments not to exceed a total term of two years; and

**WHEREAS**, the County wishes to exercise its option to extend the term for one year on the same terms and conditions.

**NOW, THEREFORE**, the parties agree as follows:

1. Article 3. "EFFECTIVE DATE AND TERM" a new subparagraph "A" is inserted to read as follows:

A. By Amendment No. 2, the term of this Agreement is extended for one year. Such term shall commence on September 4, 2015 and terminate September 4, 2016.

2. All other provisions of the Agreement No. 2015-0006-HH/MM not specifically amended or modified by Amendment No. 1 and this Amendment No. 2, shall remain in full force and effect.


