

**SANTA FE COUNTY
AMENDMENT NO. 2
TO THE PROFESSIONAL SERVICES AGREEMENT
WITH CAPITAL CITY CAB
TO PROVIDE CHAUFFER AND DESIGNATED DRIVER (CADDy) SERVICES**

THIS AMENDMENT is made and entered into as of this 1st day of July, 2010, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and **Capital City Cabs** (hereinafter referred to as "the Contractor").

WHEREAS, the County and the Contractor entered into a Professional Services Agreement dated June 9, 2009 in the amount of \$50,000.00;

WHEREAS, Article 18, "NO ORAL MODIFICATION; WRITTEN AMENDMENTS REQUIRED", of the Agreement allows the parties to amend the Agreement by an instrument in writing executed by the parties;

WHEREAS, pursuant to NMSA 1978, Section 13-1-126, it has been determined that Contractor is a sole source provider for the CADDy services;

WHEREAS, Amendment No. 1 to the Agreement increased compensation in the amount of \$50,000 for a total compensation amount of \$100,000.

WHEREAS, the parties desire to enter into this Amendment No. 2 to increase compensation in the amount of \$85,000 for fiscal year 2011 and to extend the term of the Agreement through June 30, 2011.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

1. Article 3, "COMPENSATION AND INVOICING", is amended to read as follows:

In no event shall the total compensation paid to Contractor under this Agreement exceed \$185,000.00, inclusive of gross receipts tax.

2. Article 4, "EFFECTIVE DATE AND TERM," is amended to read as follows:

This Agreement shall, upon due execution by all parties, become effective on July 1, 2010 and shall terminate on June 30, 2011, unless earlier terminated pursuant to Section 5, "TERMINATION," of this Agreement.

3. All other provisions of the Agreement not amended, replaced, or superseded by Amendment No. 1 or this Amendment No. 2 shall remain in full force and effect.






