

**SANTA FE COUNTY
AMENDMENT NO. 3 TO THE AGREEMENT
WITH WILSON & COMPANY, INC.
TO PROVIDE ON-CALL SURVEYING SERVICES**

THIS AMENDMENT is made and entered into this 17th day of October 2014, by and between **Santa Fe County**, hereinafter referred to as “County”, a New Mexico political subdivision, and **Wilson & Company, Inc.**, hereafter referred to as “the Contractor.”

WHEREAS, in accordance with Section 13-1-112 NMSA 1978, the County issued Request for Proposals (RFP) No. 2013-0008-PW/PL for on-call surveying services; and

WHEREAS, on October 26, 2012 the County and Contractor entered into Agreement No. 2013-0008-PW/PL-C to provide these services for a term of one (1) year; and

WHEREAS, Article 15, “NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED,” of Agreement No. 2013-0008-PW/PL-C allows the parties to amend the Agreement by an instrument in writing executed by the parties hereto; and

WHEREAS, Amendment No.1 extended the term of the Agreement for one (1) year to October 26, 2014 and Amendment No. 2 increased compensation by \$50,000 for a not to exceed amount of \$100,000; and

WHEREAS, the parties desire to enter into this Amendment No. 3 to increase compensation by \$50,000 and extend the term for one (1) year to October 26, 2015.

NOW THEREFORE, both parties agree as follows:

1. ARTICLE 2. “COMPENSATION, INVOICING, AND SET-OFF” a new subparagraph “2.b” is inserted to read as follows:

- b. By Amendment No. 3, the total amount payable to the Contractor under this Agreement, for the term of October 25, 2014 to October 25, 2015 shall be fifty thousand dollars (\$50,000) exclusive of gross receipts tax. The compensation payable to the Contractor for the term of this Agreement shall not exceed one hundred thousand fifty dollars (\$150,000) exclusive of gross receipts tax.


2. ARTICLE 3. “EFFECTIVE DATE AND TERM” a new subparagraph “3.b” is inserted to read as follow:

- b. By Amendment No. 3, the County notifies Contractor and exercise the County’s option to extend the term of this Agreement for one (1) year from October 26, 2014 to October 26, 2015 on the same terms and conditions as stated in Agreement No. 2013-0008- PW/PL-C.

3. All other provisions of Agreement No. 2013-0008-PW/PL-C not specifically amended or modified by this Amendment No. 3 shall remain in full force and effect.
