

**AMENDMENT NO. 4 TO
PROFESSIONAL SERVICES AGREEMENT BETWEEN
SANTA FE COUNTY AND INTERA, INC.**

THIS AMENDMENT is made and entered into on this ~~24th~~ day of April, 2015, by and between **Santa Fe County**, hereinafter referred to as the "County" and **Intera Inc.**, a Texas corporation registered to do business in the State of New Mexico, with a corporate address 6000 Uptown Blvd, NE #100, Albuquerque, NM 87110, hereinafter as the "Contractor."

WHEREAS, pursuant to a proper procurement, the County and Contractor entered into Agreement No. 2011-0224-CSD/MS (the "Agreement") on August 30, 2011 to provide for the Contractor's provision of environmental remediation and monitoring services at the County Courthouse Complex as part of the County's Voluntary Remediation Agreement (VRA) with the New Mexico Environment Department; and

WHEREAS, pursuant to Section 3 of the Agreement, by Amendment No.1 the County extended the term of the Agreement through August 30, 2013; by Amendment No. 2 extended the term through August 30, 2014 and increased the Contractor's compensation by \$95,624.30 for a total contract sum of \$363,768.80; and by Amendment No. 3 extended the term through August 30, 2015; and

WHEREAS, the County requires Contractor to continue certain environmental monitoring, testing and remediation services on the County Courthouse Complex through August 30, 2015, and the County wishes to increase the Contractor's compensation by \$35,870.00 resulting in a total contract sum of \$399,638.80.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. Section 2. COMPENSATION, insert the following as subsection "5":

5. Not-To-Exceed Amount for the period of August 30, 2014 through August 30, 2015. In no event shall the total compensation paid to Contractor for Task 4 (Document Review), Task 5 (Groundwater Monitoring), and Task 10 (Voluntary Remediation Activities) services provided through August 30, 2015 exceed the contract sum of this Agreement, exclusive of NM grt.

The contract sum for this Agreement, as amended, is Three Hundred Ninety Nine Thousand Six Hundred Thirty Eight Dollars and Eighty Cents (\$399,638.80), exclusive of NM grt.

2. All other provisions of Agreement No. 2011-0224-CSD/MS not specifically amended or modified by Amendment Nos. 1, 2, 3 and this Amendment No. 4, shall remain in full force and effect.






