

**SANTA FE COUNTY  
AMENDMENT NO. 2 TO  
PROFESSIONAL SERVICES AGREEMENT  
BETWEEN  
SANTA FE COUNTY AND MAXIMUM STAFFING SOLUTIONS  
FOR TEMPORARY NURSING SERVICES**

**THIS AMENDMENT** is made and entered into on this 17<sup>th</sup> day of December, 2013 by and between **Santa Fe County** (hereinafter referred to as the "County"), a New Mexico political subdivision, and **Maxim Healthcare Services Inc., dba Maxim Staffing Solutions**, located at 7227 Lee Deforest Drive, Columbia, Maryland 21046 (hereinafter referred to as the "Contractor").

**WHEREAS**, in accordance with NMSA 1978, Section 13-1-112, the County issued Request for Proposals (RFP) No. 2012-0131-CORR/PL for Temporary Nursing Services for the Santa Fe County Corrections Department;

**WHEREAS**, the Contractor has been providing temporary nursing services throughout 2012 and 2013 and the County needs Contractor to continue providing services;

**WHEREAS**, pursuant to Amendment No. 1 to Agreement No. 2012-0131 A-CORR/PL, the term of the Agreement will expire February 28, 2014 and according to Section 4 (Effective Date and Term) of the Agreement, the County has the option to extend the term of the Agreement for two (2) more years;

**WHEREAS**, pursuant to Section 4 (Effective Date and Term) and Section 15 (Amendment) the County desires to amend Agreement No. 2012-0131 A-CORR/PL to extend the term of the Agreement for two (2) years to February 28, 2015;

**WHEREAS**, by this Amendment No. 2 the term will be extended two (2) years on the same terms and conditions as stated in the initial agreement.

**NOW THEREFORE**, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

1. Paragraph 4 of Agreement No. 2012-0131 A-CORR/PL is amended by inserting the following provision as subparagraph "4.2":

4.2 Pursuant to Amendment No. 2, the term of this Agreement is extended two (2) years. This Agreement shall terminate February 28, 2015, unless earlier terminated pursuant to Section 5 (Termination), or Section 6 (Appropriations and Authorizations), of this Agreement.

2. All other provisions of Agreement No. 2012-0131 A-CORR/PL, including the rates stated in Exhibit A to the Agreement, not specifically amended or modified by Amendment No.

1 and this Amendment No. 2, shall remain in full force and effect.






