

**AMENDMENT NO. 2 TO
PROFESSIONAL SERVICES AGREEMENT
BETWEEN SANTA FE COUNTY AND
FENIX FIRE SERVICES, LLC**

THIS AMENDMENT is made and entered into on this 29 day of August, 2014, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as the "County"), and **Fenix Fire Services, LLC**, with physical address of 30 Holli Loop, Edgewood, NM 87015 (hereinafter referred to as the "Contractor").

WHEREAS, the County and the Contractor entered into Agreement No. 2012-0258-FD/MS on September 1, 2012 to provide for Contractor's provision for data collection, reporting and records management on national and state information, as they relate to volunteer fire and emergency medical services districts;

WHEREAS, pursuant to Section 15. NO ORAL MODIFICATIONS; WRITTEN AMENDMENTS REQUIRED, the Agreement may be amended by an instrument in writing executed by the parties;

WHEREAS, by Amendment No. 1 the Agreement was amended to correct the compensation and term provisions, extend the term of the Agreement from September 1, 2013 to September 1, 2014, and, increase the compensation payable to the Contractor by \$58,567.00 for a not to exceed amount of \$107,447.00;

WHEREAS, by this Amendment No. 2, the County wishes to extend the term of this Agreement for an additional year to September 1, 2015 and increase the Contractor's compensation by \$60,000 for a not to exceed Agreement amount of \$167,447.00;

WHEREAS, both parties desire to enter into this Amendment No. 2;

NOW THEREFORE, in consideration of the premises and mutual obligations herein, the parties hereto do mutually agree as follows:

1. Paragraph 2.A.2), delete the reference to "**Forty Eight Thousand Eight Hundred Eighty Dollars and No Cents (48,880.00)**" and replace it with "**One Hundred Sixty-Seven Thousand Four Hundred Forty-Seven Dollars and No Cents (\$167, 447.00).**"
2. Paragraph 2.A, insert a new sub paragraph 2 (ii) to read as follows:

(ii) By Amendment No. 2, pursuant to Paragraph 3 the County exercised its second option to extend the term of this Agreement for one (1) year and increase the compensation payable to the Contractor. The amount payable to the Contractor for the term September 1, 2014 to September 1, 2015 shall not exceed Sixty Thousand Dollars (\$60,000), exclusive of New Mexico gross receipt tax. The total compensation payable to the Contractor under this Agreement, as amended, shall not exceed One Hundred Sixty-

Seven Thousand Four Hundred Forty-Seven Dollars and no cents (\$167,447.00) exclusive of New Mexico gross receipt tax.


3. Paragraph 3, insert a subparagraph "B" to read as follows:

B. Pursuant to Amendment No. 2 and the County's exercise of its second option to extend the term, the Term of this Agreement is extended commencing September 1, 2014 and shall terminate September 1, 2015.

4. All other provisions of Agreement No. 2012-0258-FD/MS not specifically amended by Amendment No. 1 and this Amendment No. 2, shall remain in full force and effect.


