

**AMENDMENT NO. 2  
TO  
PROFESSIONAL SERVICES AGREEMENT BETWEEN  
SANTA FE COUNTY AND  
THE BROWN LAW FIRM FOR LEGAL SERVICES.**

**THIS AMENDMENT** is made and entered into as of this 8 day of December, 2011, by and between **Santa Fe County**, a political subdivision of the State of New Mexico (hereinafter referred to as "the County") and Brown Law Firm, LLC, a New Mexico corporation with a principal address located at 2901 Juan Tabo NE, Suite 208, Albuquerque, NM 87112 (hereinafter referred to as "Contractor").

**WHEREAS**, pursuant to NMSA 1978, § 13-1-112, the County procured Agreement No. 29-0039-LG/JC with Contractor to provide general legal services for Santa Fe County;

**WHEREAS**, since the Agreement was executed in 2009, the partners of Brown & German, LLC, dissolved their practice and attorney Kevin Brown, who established the "Brown Law Firm," has continued to represent and provide legal services to Santa Fe County under Professional Services Agreement 29-0039-LG/JC;

**WHEREAS**, by Amendment No. 1 this Agreement was amended to change the contractor's name from "Brown & German, LLC" to the "Brown Law Firm" and the Brown Law Firm continues to provide legal services to the County under the terms and conditions of Professional Services Agreement 29-0039-LG/JC;

**WHEREAS**, Article 17 of the Agreement allows for amendment of the Agreement in writing executed by the parties;


**WHEREAS**, the parties desire to amend the Agreement to clarify the attorneys who are part of the Brown Law Firm under Agreement 29-0039-LG/JC.

**NOW, THEREFORE, IT IS AGREED AS FOLLOWS:**

1. Paragraph 3. Compensation and Invoicing, A.1.i) is amended by deleting this subparagraph i) and replacing it with:
  - i) Attorney Kevin Brown at the hourly rate of \$150.00;
2. Paragraph 3. Compensation and Invoicing, A.1.ii) is amended by deleting this subparagraph ii) and replacing with:
  - ii) All other Attorneys at the hourly rate of \$120.00;
3. All other provisions of the Professional Services Agreement No. 29-0039-LG/JC not specifically amended by this Amendment No. 2 remain in full force and effect.




