

**SANTA FE COUNTY
AMENDMENT NO. 1
TO THE ADDENDUM TO MAINTENANCE AGREEMENT
WITH ROCKY MOUNTAIN BUSINESS SYSTEMS REGARDING
COPY MACHINE GA045**

THIS AMENDMENT is made and entered into as of this 28 day of April, 2011, by and between Santa Fe County, a political subdivision of the State of New Mexico (hereinafter the "County"), and Rocky Mountain Business Systems, whose principal address is 11 Plaza La Prensa #7, Santa Fe, NM 87507 (hereinafter "Contractor.")

WHEREAS, On August 5, 2010, the County entered into a small purchase contract agreement ("Agreement") with Contractor pursuant to NMSA 1978, Section 13-1-125 for maintenance services for a GA045 Copy Machine for fiscal year 2011;

WHEREAS, Contractor has certified technicians who are approved to perform and conduct necessary maintenance services on the GA045 Copy Machine;

WHEREAS, under Section 2, COMPENSATION, INVOICE, AND SET-OFF, of the Agreement the total contract price for fiscal year 2011, inclusive of gross receipts tax, was \$1125.96 and such sum has been expended for the current fiscal year;

WHEREAS, the County is in need of maintenance services for the GA045 Copy Machine for fiscal year 2012 and the existing Agreement will expire on July 1, 2011;

WHEREAS, Section 16, AMENDMENT, of the Agreement provides that the Agreement cannot be amended except by an instrument in writing;

WHEREAS, according to Section 1, TERM, the Agreement commenced September 1, 2010 and shall terminate July 1, 2011, with an option to renew the Agreement for three (3) years for a total term not to exceed four (4) years; and

WHEREAS, the parties desire to amend the Agreement to extend the term of the Agreement to June 30, 2012, and increase the contract amount by \$1056.00, exclusive of gross receipts tax.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

The Agreement is amended as follows: Section 1, TERM, is amended and modified to extend the Agreement until June 30, 2012, unless terminated earlier pursuant to Section 3 of the Agreement; Section 2, COMPENSATION, INVOICING AND SET-OFF is amended only to the extent that the compensation is increased by \$1056.00, exclusive of gross receipts tax, for fiscal year 2012; all other terms, conditions and provisions of Section 1, Section 2, and the remaining Sections of the Agreement shall remain the same and in full force and effect.

IN WITNESS WHEREOF, the parties have executed this Amendment No. 1 of the Agreement as of the date first written above.
