ADOPT-A-ROAD ANTI-LITTER PROGRAM  
ADOPTION AGREEMENT**

On this 29 day of April 20011, the Stephen K Lord and Barbara Butera (name of organization), whose address is 1 Alegre Pass Santa Fe, NM 87508 and whose contact number is 505 - 421-3042 being a civic-minded resident, neighborhood, group, etc., interested in the appearance of our County and the beauty along our roads and public lands, agrees to adopt:

County Road Richards Ave.  
Beginning at East Intersection Avenida Del Sur  
Continuing to Intersection A Las Alamos  
Total Mile(s) adopted 1.9

As an Adopt-a-Road participant, I/we agree to complete the following tasks in order to help control the accumulation of litter within the above section of road:

1. In general, develop a practical plan that will influence and encourage your neighborhood and/or the public to improve the appearance of the adopted County Road.
2. Coordinate and perform a general cleanup at least twice a year.
3. Organize with the County Adopt-a-Road Coordinator to carry out the plan, and each cleanup.
4. Request a roadside safety-meeting with the County Adopt-a-Road Coordinator prior to your first cleanup. Conduct a safety-meeting/orientation for group members prior to each cleanup, and ensure that the entire group complies with all safety guidelines of the County.
5. Execute a release of liability in favor of the County.

The County commits to the following:

1. Furnishing and erecting two signs indicating the section of road under adoption and the organization responsible.
2. Assisting in securing media coverage to inform the public of the program.
3. Providing safety instruction furnished by the program coordinator for the organization.
4. Providing and collecting bags on or shortly after cleanup day if sufficient advance notice of the cleanup is provided by the organization.
5. The County, in its sole discretion, reserves the right to terminate this agreement at any time and remove the section identification signs.
