# Q & A for the Sustainable Land Development Code

In preparation for the public meetings on May 28 and June 25, I wanted to share responses from Land Use staff on some of your questions regarding the Zoning maps for our Land Use Ordinance.

Question 1: The zoning map says my lot should be 2.5 acres but my lot is smaller than that – what happens to me?

Answer: As your lot has already been created and is a legal lot, you can do all the things allowed in that zoning district including building a house. You cannot, however, further subdivide your property as the minimum lot size that can now be created is 2.5 acres.

Question 2: My community has an approved Community Plan from the commission. Why is it not included in the Land Use ordinance being proposed?

Answer: Staff have tried to find the closest match from the approved base zoning districts in the SLDC to the districts in existing community Ordinances. The "closest match" to the base zoning districts are reflected on the adoption draft of the zoning map. Throughout the process of approving the Sustainable Growth Management Plan (SGMP) and Sustainable Land Development Code (SLDC) staff have highlighted the need to review community plans to ensure they are consistent with the SGMP and then to create an overlay district consistent with the SLDC. Staff is working on a procedure to streamline the process of writing the community overlay districts and incorporate these in Chapter 9 of the SLDC.
