AN ORDINANCE CREATING A

SANTA FE COUNTY FAIR ASSOCIATION BOARD

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE COUNTY:

PURPOSE: For the promotion and development of youth, agricultural, home economics, creative art skills and such activities of interest in Santa Fe County by holding an annual fair and such other public exhibits as may be determined by the Santa Fe County Fair Association Board.

APPOINTMENT OF BOARD MEMBERS: The Santa Fe Board of County Commissioners shall appoint a Santa Fe County Fair Association Board consisting of not less than nine members. The Santa Fe County Fair Association will make recommendations regarding said appointments to the Santa Fe Board of County Commissioners. The Santa Fe County Fair Association Board members will serve at the pleasure of the Santa Fe Board of County Commissioners. The Santa Fe County Fair Association Board shall establish policies concerning the management, conduct and activities of the Santa Fe County Fair Association and also regarding notice and conduct of its' meetings which notice shall be in a conspicuous place at the Santa Fe County Courthouse building.

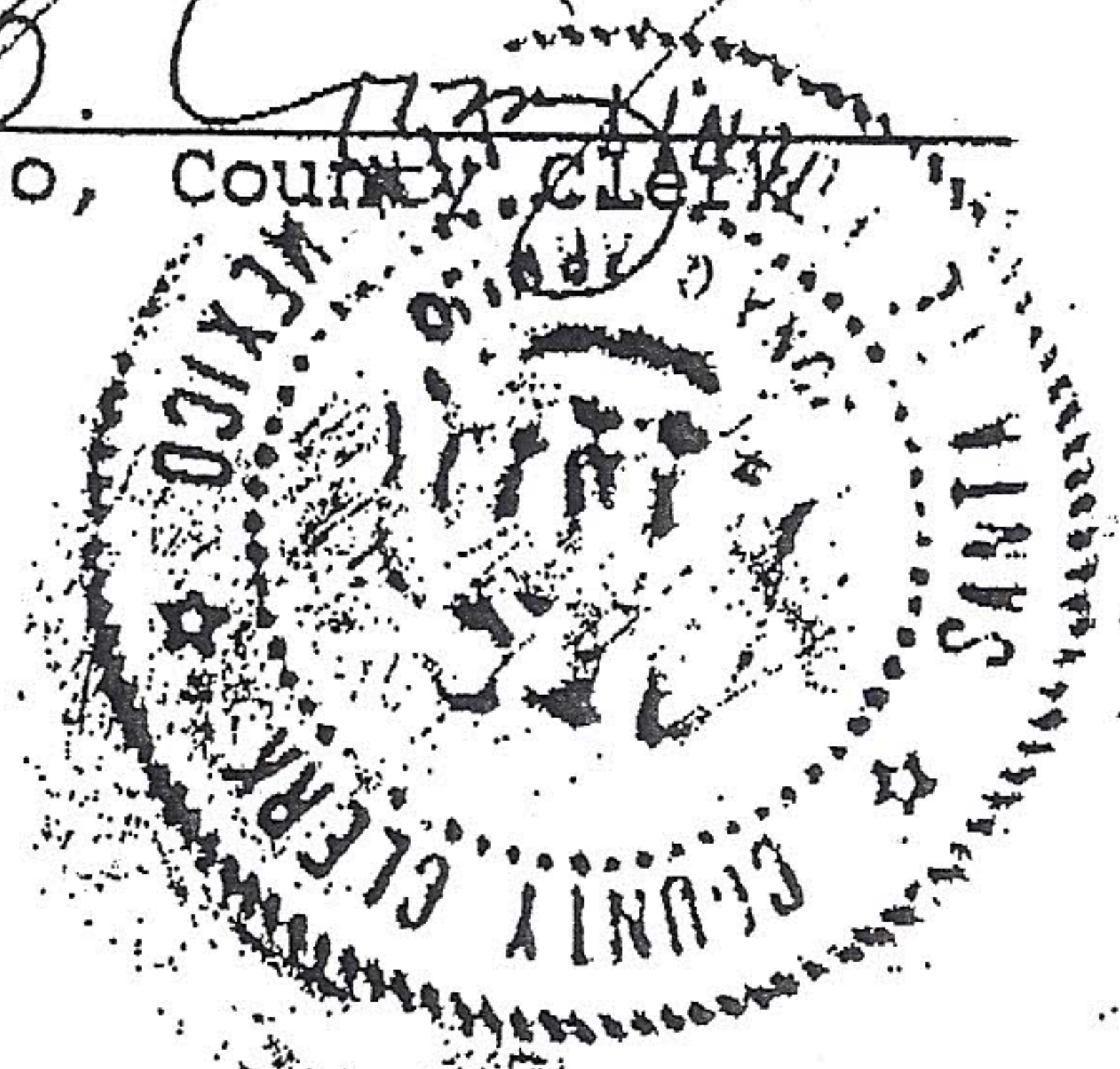

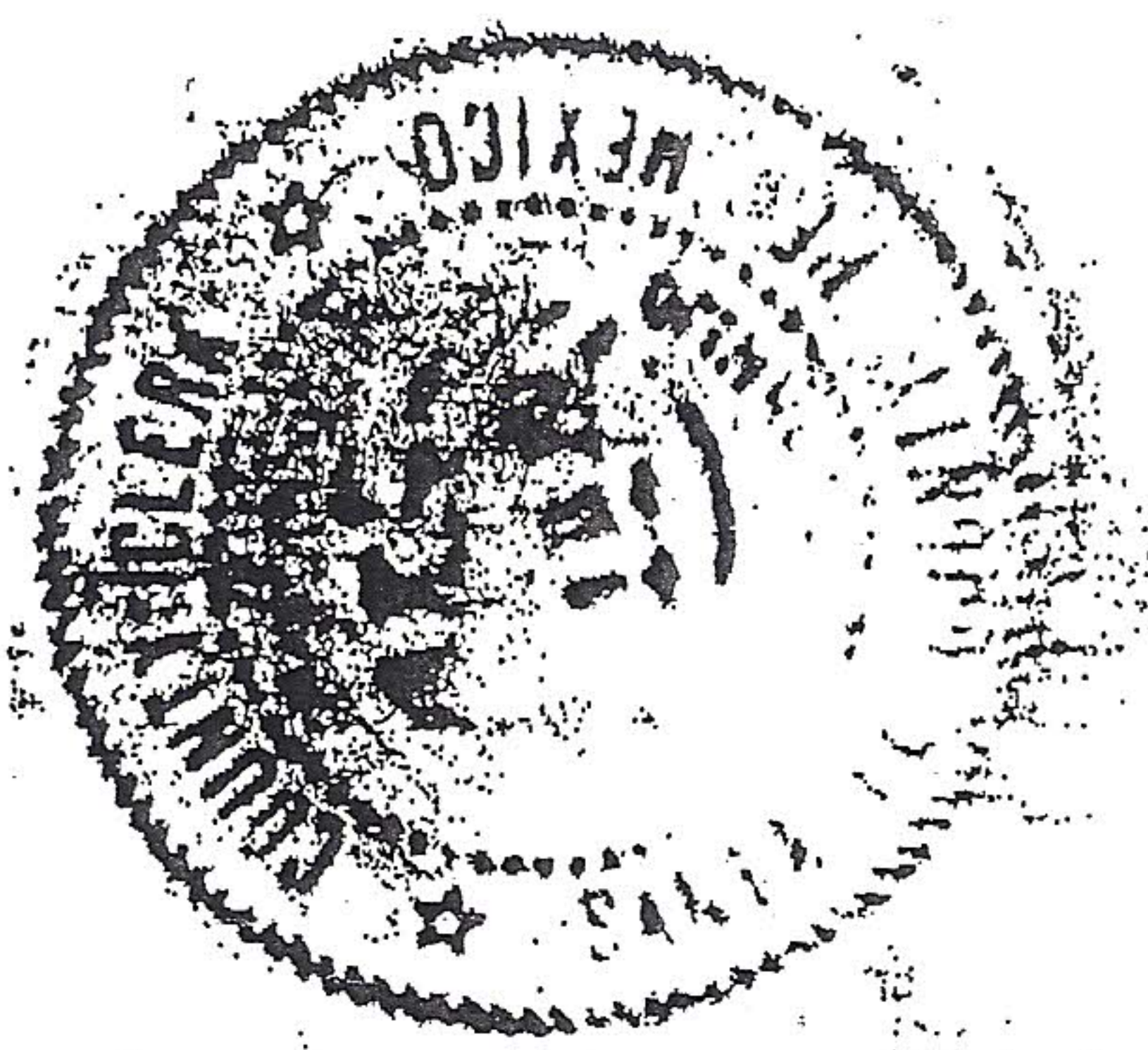
