**ORDER EXTENDING CERTAIN DEADLINES  
PROPERTY TAX DIVISION  
STATE ASSESSED PROPERTIES BUREAU,  
STATE OF NEW MEXICO**

Pursuant to my authority under Section 7-38-85 NMSA 1978, I hereby extend the following deadline found in Section 7-38-20 of the Property Tax Code with respect to the 2019-tax year only:

- 1) The deadline to allocate and certify valuations to county assessors is extended from June 3, 2019 to June 14, 2019.
- 2) Therefore, County Assessor's deadline to allocate and certify valuations to the Property Tax Division is extended from June 15, 2019 to June 28, 2019.
