2. You may be asked to install a Cisco WebEx Meeting
3. After it's installed and launched, enter your information
4. Before you join the meeting, you can choose how to connect audio
5. Toggle Audio and Video by clicking on the microphone and camera icons
6. Once you're satisfied with those selections click "Join Meeting"
7. Presenters with items on the agenda will be taken off of mute and will be asked to share their screen. (Click share content to share your screen) When your presentation is over:
 - a. Move your mouse to the center of the top of the screen.
 - b. Click Stop Sharing
8. During Public Comment, members of the public will have the ability to share information with the committee. They must sign up to comment using the chat feature. To do so, click on the chat icon.
